## SCCC NOTES

The unofficial talk-in frequency on the days of the club meetings is 145.48 MHz (down 600 kHz), the SCDXC repeater. Keep in mind this repeater is primarily for DX announcements and has a one minute time out timer (resets after the repeater carrier drops). Transmissions should be kept short. I normally monitor the repeater from home as well and can be reached on it after work and on weekends.

## LOS ANGELES AREA COORDINATOR'S REPORT

My appeal to the L.A. area ops for antenna work has so far netted mediocre results. One would think that all the Los Angeles contesters' antenna systems were in excellent repair, which we know is not the case. Remember, you supply the pizza, beer, and several weeks advance notice of your antenna raising party, and I'll do my best to round up a crew and head over at the appointed time.

The fruits of our efforts so far? W6AQ has a new two element phased array on 80 (still working out the bugs) and W6UE is getting a new two element KLM on 40 and two double extended Zepps for 80. Still working on N6AA...(anyone got a match and some kindling?).

WA6OTU on the other hand still hasn't got on HF...my gear still sits, awaiting an antenna for the new QTH...maybe that will happen soon.

Talk about antennas? There's a lot you can do that's fairly low cost and fairly unobtrusive (sometimes) on 40 and 80 meters. You don't have to be satisfied with the directivity and gain of a sloper, when you can have loops, wire beams, bobtails, phased verticals, etc. If 80 next fall and winter is anything like this last year (it'll probably be even better), NOW IS THE TIME to put up the antenna and work the bugs out of it.

1983 CQ WORLDWIDE DX CW CONTEST...XE2SI MULTI-OP, MULTI-TRANS

This was the second in a series of budget expeditions by the Southern California Contest Club. The operation took place on a hill overlooking Tijuana and San Diego. Monoband yagis were erected on 40 through 10 meters using guyed aluminum section for 40, a truck-mounted mast for 10 and trailer-mounted towers on 15 and 20. The 160-meter station featured two beverage receiving antennas. Unfortunately they did not work as expected because the preamp was easily overloaded by other transmitters. Rigs were Drake 4-lines and one Collins S-line.

A great many thanks are due to the members of the Tijuana Radio Club for their help in getting the necessary permits and smoothing the way for our convoy of unusual-looking vehicles which otherwise would surely have much delay at the border. Our thanks, too, to the Mexican Army for allowing us the use of their site and for their friendly visits to see if we were all right, and to N6NB, N6AA and the other Southern California hams who kindly lent us antennas and equipment.

This contest, as do most, provided a shakedown for our portable stations. We found plenty of things to fix or build for the next time and our list of things not to forget has grown as a result of a few forehead-slappers.
